| EXPLANATION: We currently have a contract for ten(10) Kyocera copiers on a five(5) year lease from DEX Imaging, Inc. for all other departments. The current lease started in July 2022 and includes remote management which provides highly secure cloud-based monitoring, and fax capabilities for two(2) of those departments. Our IT department continuously works with DEX Imaging, Inc. to ensure all internal and local networking, cybersecurity, technology solutions are being met. Consistency among the copiers is imperative to maintain monitoring controls between our IT department and DEX Imaging. Comparative analysis was made to the Clerk's existing Xerox and County's piggyback contracts. DEX is \$133 more annually, for all four copiers, than the current older Xerox copiers/agreement and less than the County contract w/JM Todd Inc. | | | | | | | | | | | |
