Collier Clerk's Office Seeks Rightful Owners of Unclaimed Money

Did you forget to cash a check carefully filed away in a desk drawer? Everyone likes to find forgotten money. Did you know that you might also find money that belongs to you at the Collier Clerk's Office? Just look for your name on our lists of outstanding checks, and if it's there, hurry and claim your money.

Collier Clerk Crystal Kinzel wants to remind you that the two lists of uncashed checks, those issued by the Clerk's Office and the other by the Board of County Commissioners, are updated monthly and available for viewing on the Clerk's website, CollierClerk.com -<u>Unclaimed Monies</u>. As of June 30, the combined total was over \$8.9 million in outstanding checks payable to individuals and businesses for reasons that include jury duty compensation, overpaid court fees and vendor payments. The checks, in various amounts ranging from 1 cent to over \$1 million, were either received but never cashed by the recipient, or were returned by the post office because the addressee moved without providing a forwarding address.

"This money belongs to our citizens, and we want them to have what is rightfully theirs," said Clerk

"Whether you are an individual or Crystal Kinzel. business, please make sure to look for your name on the unclaimed checks lists and help us by spreading the word to others. We would hate to see this money go unclaimed."

If your name appears and you believe that you have a valid claim to funds, follow the directions to complete the appropriate affidavit. (\$). sufficiently Claimants must prove Unclaimed ownership which includes providing a valid **Monies** government issued photo identification

and a notarized affidavit.

Florida's "Red Flag Law" and Risk Protection Orders

Mass shootings have taken over national headlines, prompting cries for gun safety legislation and leaving an indelible mark on our Country and The Sunshine State.

In February 2017, a 17-year-old expelled student returned to his former school with his legally purchased AR-15 rifle and committed what would become one of the deadliest High School shootings in American History. The incident in Parkland, Florida left 17 people dead and another 17 injured. One year later, The Florida Legislature responded by passing Florida Statutes sect. 790.401, more commonly known as *The Marjory Stoneman Douglas High School Public Safety Act or the "Red Flag Law"*. The design of the law is to "enhance public safety by restricting firearm and ammunition possession by a person who poses a danger to himself or herself or others."

How does a Risk Protection Order work? Who can file one? What does this mean for those who have their property seized?

- Only Law Enforcement may ask a court to enter a Risk Protection Order against someone that may be a danger to themselves or others. An individual can make a request; however, they would need to contact their local Police Department or Sheriff's Office. That individual would need to provide Law Enforcement with information regarding the person, including their current mental condition, any threats or acts of violence that were made and any other facts that raise a concern for safety. A description of the firearms and ammunition in question would need to be provided to help Law Enforcement thoroughly assess the situation.
- Once Law Enforcement has been notified of a potentially dangerous individual, they must investigate the claim to determine if they should petition the court for a Risk Protection Order.
- Should the Respondent meet the criteria for a Risk Protection Order, Law Enforcement will file a petition and affidavit with the Clerk of Courts, who in return will enter the case and the court will set a hearing that day for a Temporary Risk Protection Order. The temporary order will set a hearing for a Final Risk Protection Order within 14 days.
- If a Risk Protection Order has been granted, the Respondent must immediately surrender all his or her firearms, ammunition, and any license to carry a concealed weapon or firearm to the Law Enforcement officer who serves the order to the Respondent. Law Enforcement would then schedule a Compliance Hearing within three days, where the Respondent must show proof that they've surrendered all guns and ammunition.
- The Risk Protection Order will remain in place until the date written on the order. The maximum time for an order is one year, but it can be extended if the court sees fit.
- Once a protection order has been entered, the Respondent may make one written request for a hearing to vacate the order. During the hearing, they have the burden of proving, by clear and convincing evidence, that the order should be vacated based on reasons set out in the Florida Statutes.
- During the time the Risk Protection Order is in effect, the Respondent will be prohibited from purchasing, attempting to purchase, receiving, or possessing any firearm or ammunition for that specified period.
- Within 30 days prior to the expiration of the order, Law Enforcement may file a motion to extend the order and the court will hold a hearing to determine if the order should be extended. In the event the Risk Protection Order is extended, the Respondent would have another opportunity to submit a request to vacate the order.
- Should the Risk Protection Order be vacated or end without extension, Law Enforcement will return all seized guns and ammunition, after confirming through a background check that the Respondent is currently eligible to own or possess such materials.

Gun safety has become a prominent issue in the State of Florida and throughout the country. Since the Marjory Stoneman Douglas High School Public Safety Act became effective, Florida has issued 8,969 emergency risk protection orders including 72 cases in Collier County.

National Whistleblower Appreciation Day

On July 30, 1778 America's first whistleblower law was passed during the height of the American Revolution, which affirmed:

"That it is the duty of all persons in the service of the United States, as well as all other inhabitants thereof, to give the earliest information to Congress or any other proper authority of any misconduct, frauds or misdemeanors committed by any persons in the service of these states, which may come to their knowledge."

In recognition, the United States Senate recognized National Whistleblower Appreciation Day on July 30, 2013. This day celebrates the people who raise their voice in the name of combatting fraud, corruption, and other crimes. It commends the courage, strength of conviction, and dedication to the truth of whistleblowers.

The Inspector General, working with whistleblowers, recover billions of taxpayer dollars annually and help establish controls designed to prevent further waste, fraud, abuse, and/or corruption. In Florida, a whistleblower who reports gross mismanagement, malfeasance, misfeasance, gross waste of public funds, suspected or actual fraud or abuse, or gross neglect of duty is protected by Florida Statute §112.3187 (Whistleblower's Act).

What is a whistleblower?

A whistleblower is someone who brings wrongdoing by an employer or by other employees to the attention of a government or law enforcement agency. A whistleblower typically (but not always) works inside of the organization where the wrongdoing is taking place.

Is there a confidential hotline to report suspected fraud or wrongdoing in Collier County?

The Collier County Clerk & Comptroller has established a confidential hotline that serves as an effective mechanism for preventing and detecting fraud, theft, or abuse of county dollars and resources carried out by any person, business, or organization that has a relationship with Collier County Government-Board of County Commissioners or the Collier County Clerk of Court to include:

•Contractors, Subcontractors, Vendors, Employees, Volunteers, Entities, Agencies, Organizations and Officials

Report suspected fraud or wrongdoing, 24-hours a day, 7 days a week, in English or Spanish. Call our confidential hotline at 844-ClerkIG (7544) or call us locally at 239-252-8412. Another option is to click on the "Reporting Fraud" button located on the homepage of www.CollierClerk.com.

Question: Does your office audit not-for-profit organizations?

Answer: : The Clerk may audit or review Not-For-Profit (NFP) entities, as it relates to business with the Clerk or the Board of County Commissioners. For example, if a NFP applies for a County grant, the Clerk has broad powers to review documentation submitted and supporting books and records, to substantiate the request. Additionally, if a NFP is raising funds on behalf of a County program or a County property, or on a County property, the Clerk may also review the activities of the NFP. Any information which indicates


potential criminal activity is referred to law enforcement by the Clerk's Office of Inspector General.

The public is encouraged to review the NFP's annual filings with the IRS (https://www.irs.gov/charities-and-nonprofits) and their registered status in Florida (https://csapp.fdacs.gov/CSPublicApp/CheckACharity/CheckACharity/stapp), to ensure that their dollars contributed are being spent as intended.


Question: Is there a notification option available to help you remember your court date?

Answer: E-Notify is a service that provides registered users with text and email reminders of upcoming criminal court dates. Similar systems are commonly used by doctors and dentists to send appointment reminders to patients by text and email.

The service was implemented statewide with the aim of lowering "failures-to-appear" rates for adult felony, adult misdemeanor, and criminal traffic court cases.

E-Notify was developed through a collaborative effort between the Florida State Courts System, the Florida Court Clerks & Comptrollers, the Clerks of Court Operations Corporation, and the Florida Legislature. E-Notify is a courtesy service only and registration is optional.

The system is not intended to be the official record or notice of a court event and it does not replace the current practice of mailing the Notice of Hearing to defendants.
