### Intangible Tax on Real Estate Mortgages (FS 199)

Nonrecurring tax on notes, bonds or other obligation for payment of money secured by mortgage, deed or trust or other written specific lien in the nature of a mortgage upon real property shall be paid, at the time of recording, at the rate of 2 mills (.002) per dollar on the amount secured by real property. Amount is computed to the nearest cent (i.e. \$1.51 tax on \$752.63)

# State Documentary Tax (FS 201)

\$.70 per \$100 consideration applies to the full consideration. A minimum tax of \$.70 is required on all deeds including corrective deeds. (with a few exceptions).

If you want to provide a document to let the Clerk's Recording Department know the consideration when recording a Deed or other document transferring interest in Real Property, you may use the following information sheet (or any portion of), print and send with your Deed. Deed Consideration Info Sheet

Re-recorded documents do not require tax unless the required amount was not placed on original document.

State Documentary Tax on Mortgages or other written obligations to pay money encumbering Real Property is taxed at a rate of \$.35 per \$100, or fraction thereof, on the TOTAL amount of the note or obligation.
