ShowCase Web

ShowCase Web is a web-based version of the Clerk's court records management system. It allows public users to view non-sensitive information while allowing authorized users including judges, attorneys, and parties of record to access detailed case information.

Showcase Web Access

Logging In

1. For public access, click any option on the left of the Menu Bar. The General Public has access to basic case information and case images as prescribed by the Florida Supreme Court Administrative Order AOSC19-20.

If you are a registered user such as a Judge, Attorney, or Party of Record and you have a valid Username and Password, click **Login** and enter your information.



Using the Menu Bar

Access the various Showc ase Web features is by using the Menu Bar at the top of the window. These options include:

- Case Search (searchfor cases or parties)
- Court Events (view scheduled cases by date/time/location)
- Reports
- Disclaimer
- Login (available to registered users)

Case Search

Click Case Search. The Case Search window appears.

Enter one(1) or more criteria to search for your case(s) then click **Search**.

SEARCH TIPS

- Names are **NOT case sensitive.** It doesn't matter if you use uppercase or lowercase letters.
- If you see too many results, refine/change your criteria or add additional criteria.
- Search partial names by using the % as a wildcard. For example, if you search for SM/% the results will include names that start with the letters SMI (such as Smith, Smithers or Smithfield).
- Use Bar# to find a specific attorney. Find Bar #'s by going to www.floridabar.org
- Search for a business by entering the business name in the Last Name box. The exact spelling of business names may vary. Better results may be achieved by entering a portion of the name wrapped between % wildcard characters, for example: %yz co% will return XYZ Co, XYZ Company, and YZ Contracting.
- Show ALL parties and/or parcels on a case by unchecking the Show One Row Per Case box.

- 5. Click the **Court Room** dropdown to select the Judge's Initials, then click **Search**.
 - *Tip: Try performing your search without specifying any Judge initials to see all the Court Events* for that period of time.
